Do hereby resolve

WHEREAS it is the vision of the Kitchenuhmaykoosib Inninuwug Dibenjikewin Onaakonikewin (KI Family Law) to create a Healthy Self, Healthy Family, and a Healthy Community, and for programs and services, faith-based organizations, and traditional and spiritual teachings to work together for the benefit of all KI members; and

WHEREAS in accordance with Kitchenuhmaykoosib Inninuwug Dibenjikewin Onaakonikewin, the Dibenjikewin Onaakonikewin governance structure is responsible to Kitchenuhmaykoosib Inninuwug Chief and Council for overall governance and oversight of the following programs:

- Family Keepers (formerly Tikinagan and Family Advocates (Band Representatives))
- Family Wellbeing
- Choose Life
- Mental Health
- Healthy Babies
- Jordan's Principle
- Brighter Futures
- Nodin
- Preschool/daycare/early years
- Community well being
- Addictions programs including National Native Alcohol and Drug Abuse Program and, suboxone
- Diabetes programs
- Safe House
- Women's Shelter
- Special Needs
- School counsellors
- Programs for youth including:
- Services for youth age 16 and 17 pursuant to a Voluntary Youth Service Agreement ('VYSA") or a Community Youth Service Agreement ("CYSA").
- CCSY for youth age 18 to 21 years.
- Such other programs serving children, youth, and families as may exist from time to time; and

WHEREAS the KIDO organization is building capacity as it has taken on responsibility for delivering services to KI members, and

WHEREAS there is significant similarity between Jordan's Principal Choose Life programs and the responsibilities of DO workers, and an opportunity to ensure efficient use of resources by integrating these services as a first step in the overall implementation of the intended governance structure

THERE FOR BE IT RESOLVED that Jordan's Principle Choose Life programs be integrated within the KIDO structure, and responsible to the DO Board, for immediate implementation. Jordan's Principle Choose Life programs include:

- Safe House
- JP Navigator Program
- Special Needs Program
- Youth Land Based Program
- Mental Health Team
